7. Bids shall be opened in the presence of Bidders representatives who choose to attend on 16-8-2020 14:00 hours at the office of Itahari Sub Metropolitan City, Itahari, Sunsari, Nepal. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to NRs.97500 which shall be valid for minimum 30 days beyond the bid validity period.

8. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
